





# REPORT FROM OREGON-CALIFORNIA TRAILS ASSOCIATION

Laura Anderson, of the Mormon Trail Association, and I just finished a Zoom meeting with Jacey Albaugh, who works on public lands issues in the office of Senator Mike Lee from Utah. We discussed the 4-Trails Study Bill and the Period of Significance Act Bill (to extend to 1869 the period of significance for both the Oregon and Mormon Pioneer NHTs) as a way to start the process of finding sponsors for the bills on the House and Senate side.



I provided Ms. Albaugh with background information on the National Trails Act and its various amendments that led us to where we are today, explaining how the amendment of 1978 that brought the Mormon Pioneer and Oregon Trails into the system differed from the 1992 amendment that brought the California Trail into the system, in that the latter included various jumping off and ending points over a much longer period of significance, while the former is simply a straight line from one beginning point to one ending point with a period of significance that ends entirely too early.

We also discussed impacts on private lands, willing seller issues, energy development, and all of the other normal concerns that would come from a congressional office, and I provided real-world examples of how OCTA works with private landowners and developers to lessen effects on the trails without stopping their projects. I feel the meeting was very positive and we do plan to call on Sen. Lee's office personally while in DC next February for Hike the Hill.

Forget the Scissors; Cannon to 'Cut' Ribbon for Historic Cabin, Launch California Pioneer Day

COLOMA, Calif. – A cannon blast will cut a ceremonial ribbon for the public opening and dedication of a replica Mormon Workers Cabin, which played an integral role in the discovery of gold that led to the Gold Rush of 1849. The unique ribbon-cutting ceremony will highlight the fifth California Pioneer Day on Saturday, Nov. 4, at Marshall Gold Discovery State Historic Park in Coloma.



This year marks the 175<sup>th</sup> anniversary of the gold discovery by James Marshall at Coloma on Jan. 24, 1848. The six men who built the original Mormon Workers Cabin, all members of The Church of Jesus Christ of Latter-day Saints and discharged soldiers of the U.S. The Army of the West- Mormon Battalion, had been digging the tailrace for the sawmill in Coloma. The day after the workers completed the cabin, Marshall rushed in to tell them he had just discovered what appears to be gold in the tailrace. Historians know who discovered the gold and the exact date due to journal entries by two of those workers.

"The original cabin has been long gone, and we've had temporary buildings act as the Mormon Workers Cabin, but now this new cabin is built to last and is as historically accurate as possible," said Dennis Holland, a California historian and author who is president of the California Pioneer Heritage Foundation. "It is located in close proximity to the Sutter Sawmill, where the original cabin was, making it much easier to view how the history of the gold discovery unfolded."

After its opening on Nov. 4, the Mormon Workers Cabin will be staffed by volunteers in period clothing telling the story of these workers and the gold discovery, and how these men completed the sawmill and their other responsibilities while others left their homes and duties to search for gold

full-time. Part of their story is told in the docudrama, "More Precious Than Gold," which is shown in California schools and at the Coloma visitors center.

The California Pioneer History Day held every other year at the site of the gold discovery will be held from 10 a.m.-4 p.m. Nov. 4. It features many fun, child-friendly activities, games and entertainment that hearken to the Gold Rush days.

The parade featuring historical groups and descendants of gold discovery pioneers will be held at 10 a.m., ending at the Mormon Workers Cabin. The ceremony will feature a dedication of the cabin by Mark A. Bragg, North America West Area president for The Church of Jesus Christ of Latter-day Saints. Before the cannon "cuts" the ribbon, Dennis Amaral, California Pioneer Heritage Foundation board member who oversaw the construction of the new cabin, will deed the Mormon Workers Cabin to Barry Smith, superintendent of the Marshall Gold Discovery State Historic Park. Also planning to be in attendance are U.S. Representatives Kevin Kiley and Tom McClintock.

The California Pioneer History Day, attended in the past by thousands of history buffs and families, highlights the contributions of groups traditionally underrepresented in California's history. It includes historical exhibits and demonstrations from the Chinese Friends of the Railroad; Gold Rush Jewish Community; the Black peacetime military unit, the Buffalo Soldiers; the Mewuk Nisenan Native American tribes; the Japanese Wakamatsu Farm; and the Mormon Battalion.

"There are many groups and individuals who were instrumental in the settling and building up of California, but their stories are rarely told," said Holland. "Telling this history at the site of the gold discovery is appropriate, as that ignited the greatest rush for riches in the world and created this wonderful melting pot of people representing nearly every race and religion settling in California. That made it the most diverse state in the nation and it still is today."

During this year's California Pioneer History Day, more than two-dozen interactive exhibits and activities organized into two "tent towns" will straddle Highway 49, the main thoroughfare into Coloma.

The free event features historic reenactments and displays, a parade with descendants of early California pioneers, musical entertainment and various activities for families and children, including a cannon that shoots candy, free wagon rides, pioneer games and children's crafts.

Historical displays will demonstrate how the pioneers met their needs and how they traveled, cooked and laundered their clothes. Visitors can try their skills making bricks, candles, toys, dolls and other crafts, quilting and even cooking biscuits on a stick over a campfire. Old-time photos with pioneer shirts, skirts, dresses, and bonnets will also be available.

There will also be several historical reenactments featuring mountain men, frontier justice, an authentic medicine man mixing formularies of the day and others portraying famous historical figures.

Other demonstrations to take visitors back in time will be members of the Mormon Battalion in period uniforms reenacting the safety precautions taken as they fire a replica of the cannon purchased from Capt. John Sutter in 1848. The Pony Express will also re-create a mail hand-off and free wagon rides will be available.

The parade featuring descendants of early California pioneers, Mormon Battalion, the Ship Brooklyn, and other historical groups will gather at the old cabin at 10:30 a.m. and march to the new cabin, followed by an opening ceremony with guest speaker Rep. Tom McClintock, a member of the U.S. House of Representatives whose 4th district includes Coloma and what is referred to as the Gold Country.

California Pioneer History Day is sponsored by the California Pioneer Heritage Foundation and organized by members of The Church of Jesus Christ of Latter-day Saints throughout Northern California. Besides the Mormon Battalion, which came to California as a U.S. military unit to fight in the Mexican-American War, other members of The Church of Jesus Christ who were in California before the Gold Rush included those from the Ship Brooklyn, who fled religious persecution in the east by ship and landed in present-day San Francisco in 1846. The Latter-day Saints helped found cities, build schools, start farms, print newspapers and spark the Gold Rush. Some of their history will be told during California Pioneer History Day.

While the event is free, the state parking fee is \$10. Food concessions will be available or attendees can bring their own lunch. Maps will be available to show activity and food locations. Visitors can dress in period clothing, which adds to the fun, but is optional.

Marshall Gold Discovery State Historic Park in Coloma features a museum and visitors center, a replica of John Sutter's sawmill where gold was discovered in 1848, and many other buildings that recreate the town of Coloma during the Gold Rush. The museum will be open with free admission during California Pioneer History Day.
