As the Mormon Battalion approached the Arkansas River in September 1846, they met a small group of men who had left a company of Mormons from the south at Pueblo and were traveling back to get their families. This provided an opportunity for acting commander, Lt A J Smith, to relieve the main command of the large number of women and children who were allowed to travel and caught up with the Battalion at Fort Leavenworth. None of these women were original laundresses who left Council Bluffs with the Battalion. On September 16, 1846 Smith gave orders to Captain Nelson Higgins of Company D, assisted mostly by the spouses of the women, to escort the majority of families to Pueblo where the Mississippi Company was waiting to follow Brigham Young when he started west the following year. Traveling along the Arkansas River, they could stop at Bent's Fort on the way to equip themselves with supplies. The **Higgins detachment** included 11 soldiers, 1 adult officer servant, 9 women, 33 children (four of them officer servants), and one adult son. The men were told to rejoin the Battalion at Santa Fe.

When the main command arrived at Santa Fe in two groups, the new commander of the Mormon Battalion, Lt Col Philip St. George Cooke, gave orders on October 17 for all sick and feeble men to join the others in Pueblo under the command of Captain James Brown of Company C who directed the 2nd or **Brown detachment**. Cooke also ordered the remaining 25 women to join those in Pueblo, acknowledging the uncharted and difficult terrain going forward would be difficult. Five women and one child were eventually allowed to continue to California with their spouses who were officers. The other 20 women, most of them original laundresses, and a few children, were escorted by their spouses who convinced Colonel Doniphan to allow them to depart with their families. Hired to assist with medical needs, Dr. McIntyre was also sent with the Brown detachment. While in Santa Fe, the soldiers received their first pay covering six weeks of service from July 16 to August 31. However, the soldiers from the Higgins detachment received their pay later. Sent to collect the pay at Santa Fe, John D Lee and Howard Egan carried much of the pay back to families. Roswell Stevens, who was detached from the Brown detachment by Captain Brown, joined up with Lee and Egan on October 22 per Lee's account. Former quartermaster, Samuel Gully who resigned at Santa Fe, also traveled with Lee, Egan, and Stevens. A total of 88 soldiers after Stevens left, 20 women, 7 children/siblings, Dr. William McIntyre, and 2 adult officer servants traveled to Pueblo. The detachment retraced their trail a little and headed north along the east side of the mountain range passing near Bent's Fort to retrieve supplies and then on to Pueblo.

After the main command left Santa Fe, some men from the Higgins detachment arrived to report to duty only to be told by military leaders at Santa Fe to return to Pueblo and continue on detached duty. However soldier Thomas Woolsey who was with the Higgins detachment continued on to catch up with the main command on November 4, providing a report to Colonel Cooke about the situation. The travel became increasingly difficult and some men started suffering from the demand. Located at the Rio Grande River on November 10, Cooke decided to send another detachment back to Santa Fe, many seriously ill. Under the direction of Lt Willis, the **Willis detachment** with 59 soldiers began its way back to Santa Fe, several dying within days of leaving. Arriving at Santa Fe on December 1, Colonel Sterling Price, commander of the post, ordered them to continue to Pueblo. Traveling along the west side of the Sangre de Cristo Mountain range with little supplies, they traveled through major winter conditions. Leaving some supplies and a mule with instructions for those left behind to make their way to Turley's Ranch, the main company continued, renting quarters and buying some food at a Spanish town along the way. The group voted to attempt to travel uphill through a mountain pass with deep snow and reached Pueblo on December 20. Some men were sent back to assist those who remained behind and arrived in Pueblo in January. Thomas Woolsey and John Tippetts left Pueblo in late December and they arrived in Iowa in January 1847, carrying letters and news of the Battalion's whereabouts. Other publications include journal accounts about their stay in Pueblo/Mormontown.

Traveling from Pueblo to the Great Basin

On May 23, 1847, the detachments and part of the Mississippi Company left Pueblo. There was some concern among the men that Captain Brown intended to take the detachments to the west coast per

instructions he received from Santa Fe. On June 3 along the trail, Brigham Young sent Amasa Lyman and soldiers Thomas Woolsey, John Tippets, and Roswell Stevens who returned to Council Bluffs with Lee and Egan and were now with Brigham Young's Vanguard to intercept the detachments, reaching them on June 11. A group of soldiers from the detachments who were looking for stolen horses discovered Brigham Young's company was not far ahead and soon caught up to the company on July 4. Multiple journals recorded the excitement of this meeting.

William Clayton wrote:

"At 2½ P.M. the brethren returned from the ferry, accompanied by twelve of the Pueblo brethren from the army. They have got their discharge and by riding hard overtook us. They feel well and on arriving in camp gave three cheers, after which Prest. Young moved that we give glory to God which was done by hosannas."

Thomas Bullock recorded "12 of the Battalion travelled with us this day... Thomas S. Williams, Sergeant, John Buchanan, Allen Compton, Joel J. Terrill, Franscillas Durfee, Andrew J. Shupe, Samuel Gould, Benjamin Roberts, James Oakley, George Clarke, Thomas Bingham, William Casto."

Learning about the situation of the detachments, Brigham Young and the Council sent a letter to Amasa on July 8 with the following instructions. *"Brother Brannan direct from California, will accompany Srgt Williams to your camp. his command will go on with us, and from time to time, some of them will return to you, to assist in piloting you thro to our location in the Basin, and it is wisdom that you come on, as fast as the nature of the case will admit. We understand that the Troops have not provisions sufficient to go to the Western Coast; and their time of enlistment will expire about the time they get to our place. they will draw pay until duly discharged, if they continue to obey Council; and there is no Officer short of California who is authorized to discharge them, therefore when you come up with us; Cap.n Brown can quarter his troops in our beautiful City, which we are about to build; either on parole, detached service or some other important business, and we can have a good visit with them, while Cap.n Brown with an escort of 15 or 20 mounted men and Elder Brannan for Pilot, may gallop over to head quarters [San Francisco], get his pay, rations, and discharge, and learn the Geography of the Country."*

Some of the men who caught up to the Vanguard Company arrived in the valley early while the main body arrived on July 29, 1847. The Journal of Church History notes *"Before the companies emerged from the canyon, a water-cloud burst, which sent the water into the creeks from the mountains, with a rush and roar like thunder, resembling the opening of a flood gate. The shower spread over a large portion of the valley. The Pioneer brethren returned at the head of the companies and marched into camp with martial music. The soldiers appeared in military order, and many of them were mounted. They arrived at the lower camp of the Pioneers about 4 o'clock p.m. and subsequently made their encampment on City Creek, between the upper and lower camps. As many of their wagons were broken and their teams failing, they were under the necessity of stopping until further orders, although they had intended to proceed at once to the Bay of San Francisco... The meeting between the brethren of the Pioneers and the Battalion boys indeed a joyful one."*

A total of 158 soldiers were with the three detachments - nearly 1/3 of the Battalion force of 496. Company D was largely affected by the number of women and their accompanying spouses who were sent to Pueblo in the first two detachments. The soldiers in Company C apparently had the most sick and feeble men since it had a high percentage of men who left with the Brown and Willis detachments. Detachment members from Company A had the most combined deaths en route or at Pueblo although the Willis detachment suffered the most deaths en route to Pueblo. Company B was the most intact company arriving in California which may have been why they were detached to San Diego. In fact, all of those who remained at San Luis Rey for an extras few weeks in late March were sick and were all from the other companies.

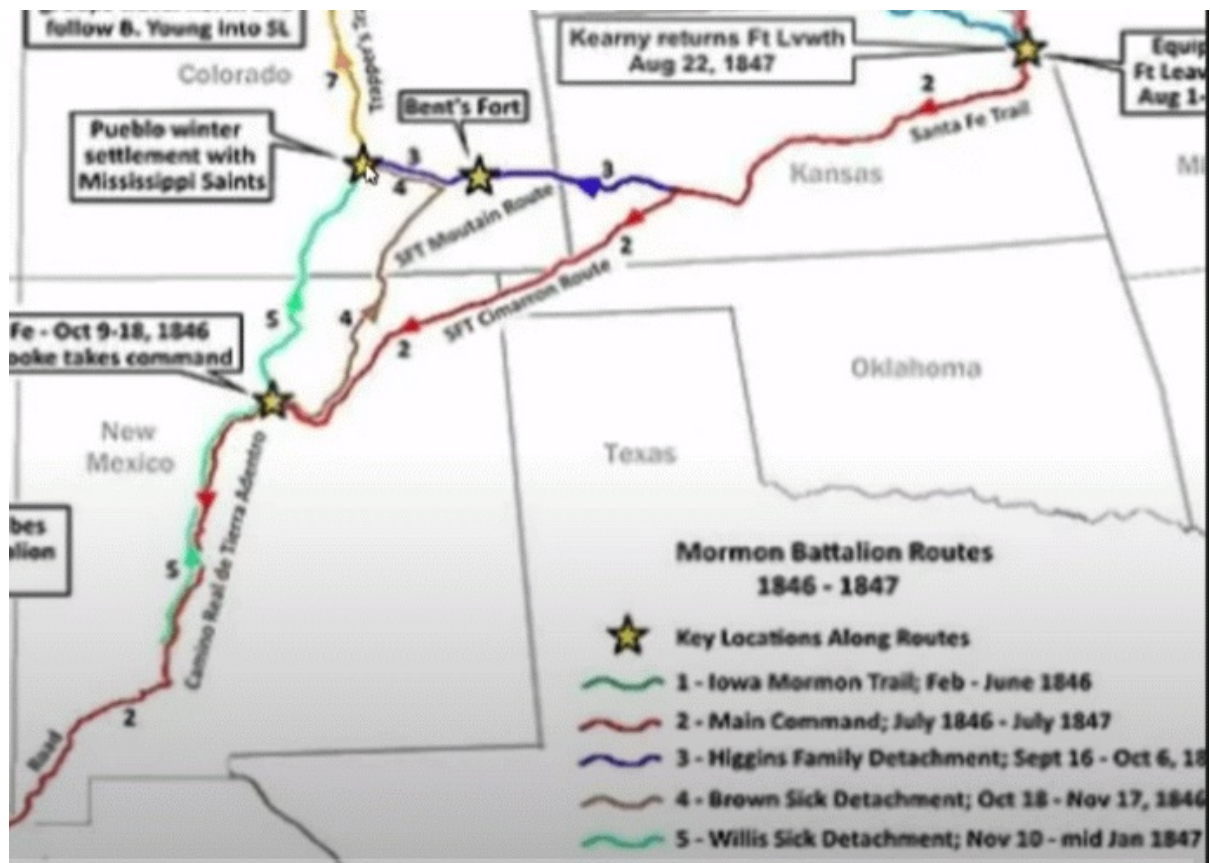

WILLIS DETACHMENT (59 soldiers left Rio Grande River between Nov 10-12, 1846 - 55 arrived in Pueblo between Dec 20 and mid January (12 A, 10 B, 15 C, 11 D, 11 E) - one duplicate, NO women. The original number varies between accounts but it appears that 55 left first and 4 others joined them a few days later.

MISSISSIPPI COMPANY

Under the direction of William Crosby and John Brown, a number of families from several southern states attempted to join Brigham Young along the trail to the west in 1846, not realizing he and the body of the Church had stopped in Council Bluffs. Often referred to as the Mississippi Saints, they eventually found a place to stay near Fort Pueblo which provided some protection and supplies. Several men traveled with the group without their families before returning back east (based on John Brown journal). Besides Crosby and Brown, the others included D. M. Thomas, William Lay, James Harmon or James Smithson, and George Bankhead. John Daniel Holladay who was with his family, left east with this group. The families spent the winter of 1846-47 in what became known as Mormon Town. As the small group of men were returning east, they crossed paths with the officers of the detachments. Between September and November, military leaders eventually sent three detachments to join the Mississippi Company.

Based on Howard Egan's journal, a small group left Pueblo early in April 1847 and camped near Fort Laramie for two weeks waiting for Brigham Young. What was referred to as the Crow Company, the group was comprised of Robert Crow's family including a married son and wife and a married daughter and her spouse and two children. Robert's child Elizabeth Jane Crow's name appears to have been left off of Howard Egan's journal which stated there were seventeen people, but only sixteen names were listed.

Three others were included in Egan's journal. Lewis B Myers, a non-member mountain man who was living at Pueblo, traveled with them. William Clayton stated "*Lewis B. Myers is represented as knowing the country to the mountains, having traveled it, and I am told that he came as a guide to brother Crow.*" Two others named in the journal were Archibald Lytle and Albert Chesney. It is unknown how these two men were related to the Crows.

This group joined up with the Vanguard Company on June 1 and several of them are mentioned in Howard Egan's journal on July 13 describing the advanced company, headed for the Salt Lake valley to help get the land ready for crops. It included the names of Robert Crow, Benjamin Crow, John Crow, Walter Crow, George W. Thirlkill, James Chesney, and Lewis B. Myers. Journal of Church history also notes that the women and children from the Crow family were with the advanced group. They arrived in the valley on July 22 according to the Journal of Church History records. Archibald Lytle [Little] left the Crow Company for Sutter's in July with Charles C Smith who had arrived with Sam Brannan on June 30. Smith arrived in California in time to inform Captain Jefferson Hunt who was located at Sutters in late August of where the Saints were headed.

Two families, the Roberds and likely the Gibsons, (neither family on the Bullock roster) remained at Pueblo as the remaining members of the Mississippi Company left with the detachments for the Great Basin. Except Lydia Gibson who married Gilbert Hunt in Pueblo, these families then traveled to Salt Lake in 1848.
